The undersigned incorporator, for the purpose of forming a corporation under the laws of Florida, adopt the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation is: Medicus Dental Centers, Inc. The purpose of the corporation is to undertake any business lawfully permitted to it.

ARTICLE II

INCORPORATORS


