ARTICLES OF INCORPORATION OF SIESTA KEY ADVENTURES, INC.

THESE ARTICLES OF INCORPORATION are hereby adopted by the undersigned incorporator of this corporation for pecuniary profits under the Florida Business Corporation Act.

ARTICLE I NAME AND LOCATION OF AGENT AND OFFICES

...

Section 1.1 Name. The name of the corporation thall be SIESTA KEY ADVENTURES, INC.

Section 1.2 <u>Principal Office and Mailing Address</u>. The corporation's principal office, if known, shall be 387 ISLAND CIRCLE, SARASOTA, FLORIDA 34242, and the mailing address of the corporation shall be 387 ISLAND CIRCLE, SARASOTA, FLORIDA 34242. The corporation may change the foregoing addresses, transact business at other places within or without the State of Florida and establish branch offices within or without the State of Florida, all as the Board of Directors may from time to time determine.

Section 1.3 <u>Initial Registered Agent and Office</u>; <u>Statement of Acceptance</u>. Section 2.2 <u>Duration</u>. The corporation shall have perpetual existence, or until dissolved according to law.

ARTICLE III PURPOSE AND POWERS

Section 3.1 <u>Purpose</u>. The general purpose for which the corporation is initially organized shall be to transact any and all lawful business for which a corporation may be incorporated under the laws of Florida, and to do everything necessary or convenient for the accomplishment of said purpose, and to do all other things incidental thereto or connected therewith that are not prohibited by law, and to carry out said purpose in any state, territory, district or possession of the United States or in any foreign country, to the extent not prohibited by law therein.

Section 3.2 <u>Powers</u>. The corporation shall have and exercise all of the corporate powers enumerated in or otherwise permitted under the Florida Business Corporation Act.
