

ARTICLES OF INCORPORATION
OF
WWC OF NAPLES, INC.

ARTICLE I - NAME

The name of this Corporation is WWC OF NAPLES, INC.

ARTICLE II - DURATION

This Corporation shall have perpetual existence.

ARTICLE III - PURPOSE

This Corporation is organized for the following purposes:

- A. To engage in the operation of real estate development and management.

- C.
