ARTICLES OF INCORPORATION

OF

INFOFARM, INC.

The undersigned incorporator, for purposes of forming a corporation under the Florida Busine Corporation Act, hereby adopt(s) the following Articles of Incorporation.

ARTICLE 1

The name of this corporation is INFOFARM, INC. The initial principal place of business of this corporation is:
