ARTICLES OF INCORPORATION

The undersigned, desiring to organize a corporation under Chapter 607, Florida Statutes, sets forth the following:

ARTICLE I

The name of the corporation shall be ENCHANTED COTTAGE, INC. The address of the principal office of the corporation and the mailing address of the corporation is 2762 Park Street, Jacksonville, Florida 32205.

ARTICLE_II

The duration of the corporation shall be perpetual.

ARTICLE III

The general purpose for which the corporation is organized shall be retail sale of antiques, gifts, art and other items, and any lawful business, for profit, for which corporations may be incorporated under Chapter 607, Florida Statutes.
