ARTICLE OF INCORPORATION

ARTICLE I

THE NAME OF THIS CORPORATION IS, BORN AGAIN BOTTLES, ETC. INC. AND THE PRINCIPAL OFFICE AND MAILING ADDRESS IS, 5214 S.W. 149TH PLACE, MIAMI, FL.

ARTICLE II

THIS CORFORATION SHALL HAVE PERPETUAL EXISTENCE UNLESS SOONER DISSOLVED BY LAW.

ARTICLE III

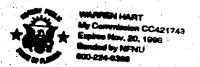

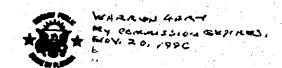
