ARTICLES OF INCORPORATION OF TALLAHASSEE FLORIDA REPAIR IT RIGHT SERVICES & MAINTENANCE, INC.

The undersigned hereby establishes the following for the purpose of becoming a Corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida providing for the formation, liability, rights, privileges and immunities of a Corporation for profit.

ARTICLE I

Name of Corporation

The name of this Corporation shall be Repair It Right Services & Maintenance, Inc. (the "Corporation").

ARTICLE II

Mailing Address

ARTICLE III

<u>Purpose</u>

This Corporation is organized for the following purposes:

(a) To have and to exercise all the powers now or hereafter conferred by the laws of the State of Florida upon corporations
