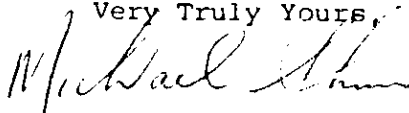

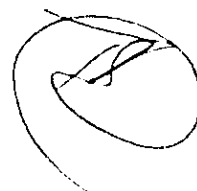

The undersigned, acting as incorporator of Printing & Stationery Depot, Inc. under the Florida Business Corporation Act, adopts the following articles of incorporation.

ARTICLE I - NAME

ARTICLE III - COMMENCEMENT OF EXISTENCE

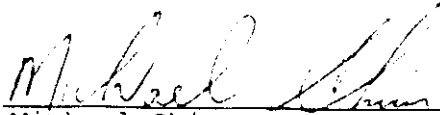
ARTICLE IX - BYLAWS

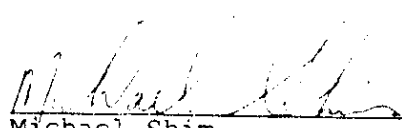
