

The undersigned, acting as the sole incorporator under the Florida General Corporation Act, adopts the following Articles of Incorporation

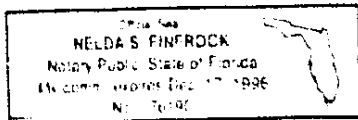
- 1 **NAME** The name of this corporation is KENEAN INC
