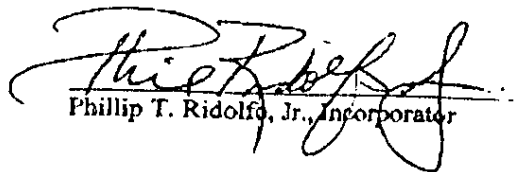
**FIFTH:** The street address of the principal office of this Corporation is 6855 102nd Place, Boynton Beach, Florida 33483.

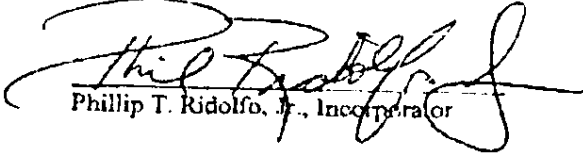

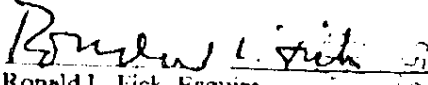
