ARTICLES OF INCORPORATION

OF

CHICAGO HOT DOG WORKS, INC.

ARTICLE 1 - Name

The name of the corporation is CHICAGO HOT DOG WORKS, INC.

ARTICLE 2 - Address

The street address of the initial principal office of the corporation is 859 Palmer Ave., Winter Park, F1, 32789. The mailing address of the corporation is the same.

ARTICLE 3 - Shares

This corporation is authorized to issue 1,000 shares of \$1.00 par value common shares. All issued shares must be represented by certificates.

ARTICLE 4 - Preemptive Rights
