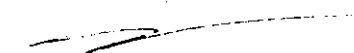
Enclosed please find the completed Articles of Incorporation per your instructions at our consultation meeting May 30, 1995.

OF

The undersigned subscribers, natural persons competent to contract, for the purposes of forming a corporation under the laws of the State of Florida, adopts the following ARTICLES OF INCORPORATION for the corporation: DeSange Trucking, Inc.

ARTICLE ONE

NAME

The name of the Corporation is DeSange Trucking, Inc.

ARTICLE TWO

DURATION

The duration of the Corporation is perpetual.

ARTICLE THREE

PURPOSE OF BUSINESS

The corporation may engage in any activity or business permitted under the Florida General Corporation Act and business authorized by the State of Florida.

ARTICLE FOUR

CAPITALIZATION

The aggregate number of shares of common stock which the Corporation shall have authority to issue is one thousand (1,000) shares which shall be common stock having a one cent (\$ 00.01) per share. Each share shall have one vote on all business affairs of the Corporation, as designated by the By-Laws.

ARTICLE SEVEN

DIRECTORS AND PRINCIPAL OFFICERS

The number of Directors shall be two or the number as adopted

The officers of this Corporation shall be the officers of the
President, Vice President, Secretary and Treasurer. The first
Board of Directors, and designated Officers shall hold office for

ARTICLE EIGHT

BY-LAWS
