The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

Pursuant to Section 607.1007, Florida Statutes, the undersigned corporation adopts the following Restated and Amended Articles of Incorporation. These Amended and Restated Articles of Incorporation completely restate and amend the Articles of Incorporation of HomeTrades Referral, Inc. filed with the Secretary of State on August 23, 1995. These Amended and Restated Articles of Incorporation were duly adopted by the unanimous consent of the Directors and Shareholders of the Corporation and all amendments included herein have been adopted pursuant to and as provided by Florida Law. There is no discrepancy between the Articles of Incorporation and the provisions of the Amended and Restated Articles of Incorporation other than the inclusion of amendments adopted pursuant to Florida Law and the omission of matters of historical interest. The date of adoption of the amended and restated articles is May 22, 1997.
