Please find enclosed our Application for Reinstatement for New Lambda Corporation and our filing fee of \$300.00. This represents our filing fee for the year 2003 and our filing fee for 2004. We would like to request at this time, a waiver of the penalties assessed for failure to file our corporate annual report/uniform business report based on the following circumstances.

New Lambda Corporation moved its corporate office from 2125 University CT, Clearwater, FL 33764 to 2401 Margolin Lane, Clearwater, FL 33764 late in the year 2002. Apparently, the post office did not forward the first and second corporate annual reports to our new corporate address. This was not realized until early 2004 when we had not received our corporate renewal form for the year 2004. After searching our records on hand and not being able to locate the annual reports for 2003 and 2004, we contacted the current lessee at 2125 University CT. and they forwarded to us some mail that they had received and were holding for New Lambda Corporation. Among this forwarded mail was our Notice of Administrative Dissolution or Revocation ( included with this letter).
