The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE ONE

DURATION

The duration of the Corporation is perpetual. The effective date of the corporation shall be the 15th day of August, 1995.



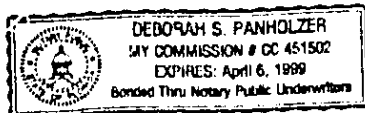
