ARTICLES OF INCORPORATION

WE, THE UNDERSIGNED, hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida providing for the formation, liability, rights, privileges and immunities of corporations for profit. TALLAHASSEE, FLORIDA

ARTICLE I, NAME

The name of this corporation shall be:

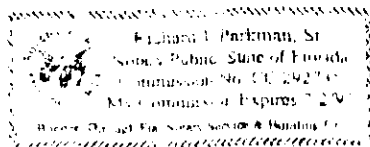
