Name

The name of the corporation is **PLD ADVANCED AUTOMATION SYSTEMS, INC.**

Article 2
Duration

This duration of this corporation is perpetual. 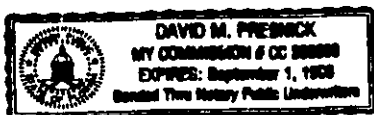

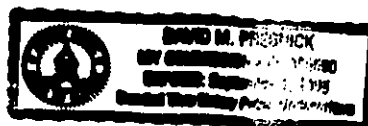
