#### ARTICLES OF INCORPORATION OF

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

#### Article 1. Name and Address

The name of the Corporation is Clipper Cove Development Corporation, Inc. The principal office, if known, or the mailing address of the Corporation is 28999 Bonita Grande Drive, Naples, Florida 33999.
