THE undersigned subscribers to these articles of incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida.

ARTICLE I

NAME: The name of this corporation shall be: R & R MEDICAL EQUIPMENT & SUPPLY, INC.
