6. The number of directors constituting the initial board of directors is one and the name and address of the director is:

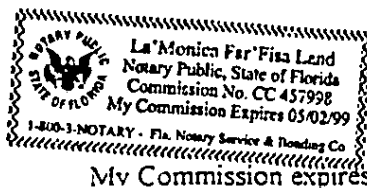
