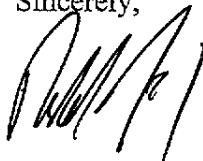

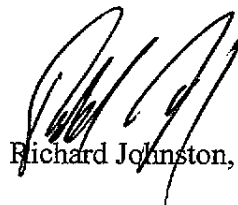

Pursuant to Section 607.1403, Florida Statutes, the undersigned corporation adopts these

Articles of Dissolution.

1. The name of the corporation is iTravel Partners, Inc. ("Corporation").
2. The dissolution was authorized by the board of directors pursuant to a resolution adopted May 22, 2001.
3. The dissolution was approved by the shareholders of the Corporation on May 25, 2001. The number of votes cast in favor of dissolution was 17,651, which represented 66% of the shares in the Corporation and which is sufficient for approval pursuant to Florida law.
4. The dissolution by these Articles of Dissolution will take effect upon the filing of these Articles with the Secretary of State of the State of Florida.
