ARTICLES OF INCORPORATION

FILED CECRETARY OF STATE BYSEL HIS CORPORATIONS

The undersigned incorporators of these Articles of Incorporation, being natural 95 MUG 24 FM12: 21 persons, competent to contract, hereby form a corporation under the laws of the State of Florida by and under the provisions of the Statutes of the State providing for the formation, liability, rights, privileges and immunities of a corporation for profit.

ARTICLE I - NAME

The name of the corporation is "Integral Enterprises, Inc." (hereinafter referred to as the "Corporation").

ARTICLE II - PURPOSES OF CORPORATION
