# DREAM CHASER EXPRESS, INC.

The undersigned, acting as incorporators of a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such corporation:

### ARTICLE I - NAME

The name of the corporation is DRRAM CHASER EXPRESS, INC.

#### ARTICLE II - TERM OF EXISTENCE

The period of duration of the corporation is perpetual.

# ARTICLE III - NATURE OF BUSINESS

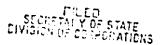
