I, the undersigned incorporator, hereby make, subscribe, acknowledge and file with the Secretary of State of the State of Florida these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with laws of the State of Florida.

This corporation shall commence on the date on which these Articles are filed with the Secretary of State.

ARTICLE IV - GENERAL NATURE OF BUSINESS

This Corporation shall be authorized to transact all legal business of any nature.

ARTICLE V - CAPITAL STOCK

This corporation is authorized to issue one thousand (1,000) shares of one dollar (\$1.00) par value common stock.
