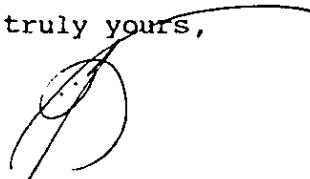

**ARTICLE I**

The name of the corporation is AGC CL LIMITED PARTNER, INC., (the "Corporation").

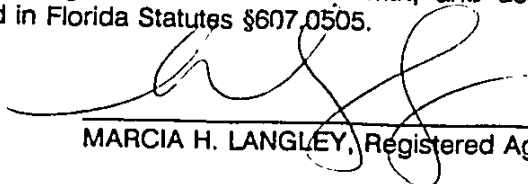
