

ARTICLES OF INCORPORATION OF JOHN'S PASS DELI & SEAFC'DD INC.



The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of incorporation for such corporation:

ARTICLE I - NAME. The name of this corporation is JOHN'S PASS DELI & SEAFOOD INC.


