under the laws of the State of Florida

ARTICLE I. NAME

The name of this corporation is:

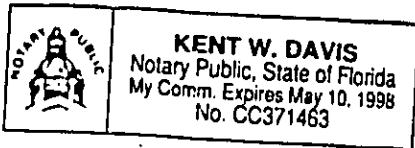
