ARTICLES OF INCORPORATION

The following shall constitute the Articles of Incorporation organizing a corporation under the laws of Florida.

Article One

Article Name

Each and every person who may become a director of the corporation is hereby relieved from any liability that might otherwise exist from thus contracting with the Corporation for the benefit of himself or any firm, association or corporation in which he may be in any way interested. Any director of the Corporation may vote upon any contract or other transaction between the Corporation and any subsidiary or controlled company without regard to the fact that he also is a director of such subsidiary or controlled company.
