ARTICLE I. CORPORATE NAME.

The name of this corporation is: **CHRISTIAN ADMINISTRATIVE SERVICES, INC.**
The principal office shall be 1820 Evergreen Avenue, Jacksonville, FL 32206.

ARTICLE II. NATURE OF BUSINESS AND POWERS.

The general nature of the business to be transacted by this Corporation is to engage in business development, joint ventures with minority and other corporations to acquire and supply goods, technical services, advisory and other services; and any and all business permitted under the laws of the State of Florida.

ARTICLE III. CAPITAL STOCK.

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is 500,000 shares of common stock having a par value of \$1.00 per share.

ARTICLE IV. TERM OF EXISTENCE.

This Corporation shall have perpetual existence commencing upon filing of these articles.
