## ARTICLES OF INCORPORATION

The undersigned, incorporator, for the purpose of forming a corporation under the Pforida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation:

## ARTICLES I: NAME OF THE CORPORATION

The name of the corporation is JTM SALES, INC., hereinafter referred to as the "Corporation".

ARTICLE VI: PREEMPTIVE RIGHTS

The Corporation elects to have preemptive rights. Every shareholder, upon the sale for

share thereof at the price at which it is offered to others.
