ARTICLE I - RAME

The name of this corporation is:

PROMPT PELIVERIES, INC.

ARTICLE II - DURATION

This corporation is to exist perpetually. It shall commence its existence upon the signing of these Arricles of Incorporation by the initial subscribers.

ARTICLE III - PURPOSE


