

ARTICLES OF INCORPORATION OF CAJUN CAFE SEMINOLE, INC.



The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the state of Florida.

ARTICLE I. NAME

The name of the corporation shall be: Cajun Cafe Seminole, Inc.


