ARTICLES OF INCORPORATION

OF

The undersioned, in order to form a corporation for the purpose hereinafter stated, under and pursuant to the General Corporation Act of the State of Florida, do hereby certify as follows:

ARTICLE

NAME

The name of this corporation is:

ARTICLE, 11

PURPOSE

The general nature of the business to transacted by this corporation shall be:

- D) To sell, manage, improve, develop, assign, transfer, convey, lease, sublease, pledge, or otherwise encumber the lands, buildings, real property, chattels, real, and other property of the corporation, real and personal, and wheresoever situate, and any and all legal or equitable rights therein.

- G) To purchase, acquire, hold, sell, assign, transfer, mortgage, pledge, and otherwise dispose of the charce of capital stock, bonds, debentures, or other evidence of indobtness of any corporation, domestic or foreign, and while the holder thereof, to exercise all the rights and privileges of ownership, including the right to vote thereon, and issue in exchange therefore its own, bonds, and other obligations.


