ARTICLES OF INCORPORATION

OF

THE MICROBREW CORPORATION

Pursuant to the provisions of the statutes of the State of Florida, providing for the formation, liability, rights, privileges and immunities of a corporation for profit, the undersigned has placed his signature and seal upon this document for the purpose of becoming a corporation under the laws of the State of Florida.

ARTICLE I-NAME

The name of the corporation is THE MICROBREW CORPORATION.

ARTICLE II-DURATION

This corporation shall have perpetual existence.

ARTICLE III-PURPOSE

This corporation is organized for the following purposes:

To engage in any lawful purpose or purposes.

ARTICLE IV-CAPITAL STOCK

This corporation is authorized to issue 500 shares of common stock with a par value of \$1.00 per share.

ARTICLE V-INITIAL REGISTERED OFFICE AND AGENT

The street address of the principal office and mailing address of the corporation is 1724 4th Street, Sarasota, Florida 34236; and the name and address of the initial registered office and agent of this corporation is: Bradford A. Peterson, 1724 4th Street, Sarasota, Florida 34236.

ARTICLE VI-INITIAL BOARD OF DIRECTORS

This corporation shall have one (1) director initially. The number of directors may be increased or diminished from time to time by the by-laws but shall never be less than one (1) and said corporation is authorized to have five (5) directors at any one time. The name and address of the initial director of this corporation is: Bradford A. Peterson, 1724 4th Street, Sarasota, Florida 34236.

ARTICLE VII-INCORPORATORS

The name and address of the person signing these Articles of Incorporation is: Bradford A. Peterson, 1724 4th Street, Sarasota, Florida 34236. The officers of this corporation shall be a president, who shall be a Director of the corporation, a vice-president, a secretary and a treasurer, and such other officers and agents as may be necessary. All officers and agents as may be necessary shall be chosen in such manner, hold office for such terms and have such powers and duties as may be prescribed by the by-laws of the corporation or determined by the Board of Directors. Any person may hold two offices, except that

the President shall not be also the secretary or assistant secretary of this corporation.

ARTICLE VIII-AMENDMENT

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.

ARTICLE IX-INDEMNIFICATION

The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

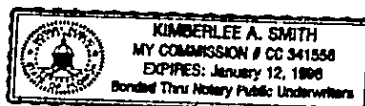
