Dear Sir or Madam:

I am writing in connection with the 2002 Uniform Business Report for the corporation referenced above. James Marvin Wimsatt, the sole owner of Construction Supply of Sarasota, Inc. ("Construction Supply"), passed away suddenly on August 24, 2001. Unfortunately, no management succession existed at the time of Mr. Wimsatt's death and the business operation was shut down on or about August 31, 2001.

Our firm represents Katherine Wimsatt Wright, Mr. Wimsatt's mother and the personal representative of his estate. Mrs. Wright is a resident of Kentucky and was not involved in the management of Construction Supply prior to her son's death. Over the last several months, Mrs. Wright and her agents have worked to collect receivables, pay off creditors, and otherwise wind down the corporation. It is hoped that the pending liquidation of the corporation will yield at least some distribution to Mr. Wimsatt's estate, and ultimately, to Mrs. Wright.

The first notice for the 2002 UBR was not received by the corporation, presumably because the business no longer operates out of the same address. I note that the second notice was mailed care of our law firm at 200 S. Orange Avenue, which is appropriate. Given that the first notice was not received, and based on the unfortunate circumstances surrounding Mr. Wimsatt's death and the closing of the business operation, we respectfully request that the fee associated with filing the 2002 UBR be reduced to \$150.00.
