The undersigned incorporator, for the purpose of becoming a Corporation under the General Corporation Laws of the State of Florida, providing for the formation, liabilities, rights, privileges and immunities of a corporation for profit, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation hereby formed under these Articles shall hence, and from this day, subject to the approval of the Secretary of State, State of Florida, be known as A A ADJUSTES, INC. The principal place of business of this corporation shall be 3000 Royal Palm Ave., Miami Beach, Florida 33140.

ARTICLE II - OBJECTIVE

A A ADJUSTES, INC. shall have as its principal business objective the operation of a primarily real estate remodeling corporation in full and complete compliance with the Laws of the State of Florida and to conduct all business purposes set forth by said statutes. However, said corporation may engage in any and all types of associated or relative businesses and may pursue any and all business objectives in accordance with the Laws of the United States, the State of Florida, or any other state, country, territory or nation.

ARTICLE III - CAPITAL STOCK

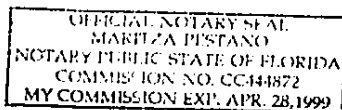
