ARTICLES OF INCORPORATION OF BRADBURY TROPHIES, INC.

ARTICLE I - NAME

The name of this corporation is BRADBURY TROPHIES, INC.

The principal address of said corporation is 18 Juniper Pass Way, Ocala, Florida.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV - CAPITAL STOCK

- 4.1 This corporation is authorized to issue 7,500 shares of \$1.00 par value common stock.

The Section is intended to expand the ability of the corporation to conduct business with interested parties and shall

not be construed to invalidate any contract of other transaction that would otherwise be valid under the common and statutory law applicable to it.

ARTICLE VIII - INITIAL REGISTERED AGENT AND OFFICE

The corporation reserves the right to amend the articles in any manner now or hereafter permitted by the law or as provided by the by-laws.


