I, the undersigned incorporator, do hereby form a corporation for profit under the general laws of the State of Florida pursuant to Section 607.0202, Florida Statutes, and do hereby certify as follows:

ARTICLE I

The name of the corporation shall be BIERA MAR LTD., INC.

ARTICLE II

The location of the principal place of business shall be 1503 Westward Ho Lane, Marathon, Florida 33050, and the mailing address of the business shall be P. O. Box 500092, Marathon, Florida 33050.

ARTICLE III

The corporation shall have perpetual existence.

ARTICLE IV

The Registered office of this corporation is 1503 Westward Ho Lane, Marathon, Florida 33050 and the name of the initial registered agent of the corporation at that address is Paul C. Kenson, Jr.

The general nature of the business to be transacted shall be the following:

- 1.
