ARTICLE 1 - NAME

The name of this corporation is MERRITT SYSTEMS COMMERCIAL, INC., located at 2425 North Courtenay Parkway, #5, Merritt Island, FL 32953.

ARTICLE II - DURATION

This corporation shall have a perpetual existence commencing upon the filing of these Articles of Incorporation by the Department of State.
