

ARTICLES OF INCORPORATION
OF

ARTICLE I

NAME

The name of this corporation is HAMILTON CONNECTIONS OF THE TREASURE COAST, INC.

ARTICLE II

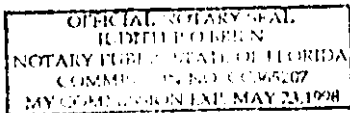
