ARTICLES OF INCORPORATION

We, the undersigned, hereby associate ourselves for the purpose of becoming a corporation under the laws of the State of Florida, providing for the formation, liabilities, rights, privileges, and immunities of a corporation for profit.

Article I NAME

The name of the corporation shall be:

ARTICLE II PRINCIPAL OFFICE

ARTICLE III DURATION OF EXISTENCE

The corporation shall have perpetual existence unless sooner dissolved according to the law.

ARTICLE IV PURPOSE

The corporation is organized for the purpose of transacting any and all lawful business, including but not limited to, the following:

- (a) To acquire the goodwill, rights, property, and assets of all kinds, to undertake the whole or any part of the liabilities of any person, firm, association, or corporation, in such terms and conditions as may be agreed upon, and to pay for the same in cash, stocks, bonds, debentures, or other securities of this corporation or otherwise.
- (b) To do any and all acts and things, and to exercise any and all other powers conferred by the laws of Florida upon corporations formed under the provisions of Chapter 607, Florida Statues, 1993, as amended, and which now or hereafter may be authorized by law.
- (C) To engage in the operation, ownership, and management of convenient stores, or any other type or form of property of every form and nature, and to own, buy, sell, or exchange any properties for that purpose.

ARTICLE V SHARES

The maximum number of shares of stock outstanding at any one time shall be 1000 shares, all of one class, common, participating voting stock.

ARTICLE VI PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class, or series as that which he already holds, shall have the right to purchase his prorata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which such stock is offered to others.


