ARTICLES OF INCORPORATION OF 95 AUG 28 PM 1:23

ARTICLE I

THE NAME OF THE CORPORATION SHALL BE: MAXHAM MANAGEMENT INC.

ARTICLE II

THE CORPORATION WILL ENGAGE IN ANY ACTIVITY PERMITTED BY THE LAWS OF THE STATE OF FLORIDA AND THE UNITED STATES OF AMERICA.

ARTICLE III

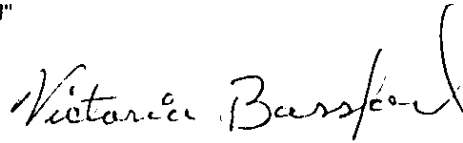
