

Attached you will find a copy of the Corporate Annual Report for Sebring Communications Inc. Document #P95000066881. I apologize for the tardiness of this Annual Report and would like to request the waiver of the \$400 penalty for the following reasons.

The Taxpayer said they never received a report from the Department of State this year. We understand this is not a strong argument for late filing, however, it did in part add to our confusion as is explained below.

This is a new client of mine that was acquired during tax season. During one of our first meetings we discussed this report and it was my understanding that the Taxpayer would file the Report.
