ARTICLES OF INCORPORATION

OF

The undersigned, desiring to organize a corporation under Chapter 607, Florida Statutes, sets forth the following:

ARTICLE I

The name of the corporation shall be GOSPEL VIDEO PRODUCTIONS, INC. The address of the principal office of the corporation and the mailing address of the corporation is 11465 Willet Court South, Jacksonville, Florida 32225.

ARTICLE II

The duration of the corporation shall be perpetual.




