ARTICLES OF INCORPORATION
OF
HYACINTH PRODUCTIONS, INC.

I, the undersigned the natural person of the age of 18 years or more, acting as the incorporator do hereby adopt the following Articles of Incorporation for such corporation:

ARTICLE I - NAME

The name of this corporation is HYACINTH PRODUCTIONS, INC.

ARTICLE III - DURATION

This corporation shall exist perpetually commencing on the date of execution and acknowledgment of these Articles.

This corporation is organized for the purposes of:

ARTICLE V - CAPITAL STOCK

The aggregate number of shares which the corporation shall have authority to issue is 7,500 of the par value of \$.10 each.

All of the issued shares of the corporation, including treasury shares,

and all of the issue securities evidencing the right to acquire shares of the corporation shall be held of record by not more than 35 persons in the aggregate.


ARTICLE XI - BY-LAWS
