THE UNDERSIGNED, incorporators to these Articles of Incorporators to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation for profit under the laws of the State of Florida.

### ARTICLE ONE

The name of this corporation is: V E L, INC.

# ARTICLE TWO

This corporation shall have perpetual existence.

#### ARTICLE THREE

This corporation shall be effective upon approval by the Secretary of State of the State of Florida.

### ARTICLE FOUR

The corporation may engage in any activity or business permitted under the laws of the United States and of this State.

### ARTICLE FIVE

The maximum number of shares that this corporation is authorized to have outstanding at any one time is 60 shares of common stock, each having no par value. The consideration to be paid for each share shall be fixed by the Board of Directors from time to tir .
