OF

ARTICLE I. NAME

The name of this corporation is ON SITE THERAPY,

ARTICLE II. DURATION

This corporation shall have perpetual existence.

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV. CAPITOL STOCK
