The undersigned all of whom are duly licensed to practice psychology in the State of Florida, desiring to form a professional corporation in accordance with Chapter 607 of the Florida Statute and the Florida Professional Service Corporation Act, adopt the following Articles of Incorporation.

I. NAME

The name of the corporation shall be Peter R. Kaplan, Ph.D., P.A.

II. PURPOSES

The purpose of which the Corporation is organized shall be to engage in and carry on all branches of the practice of psychology within the State of Florida, and to do those things that are necessary or proper in connection with that practice, including, but not limited to, the following:
