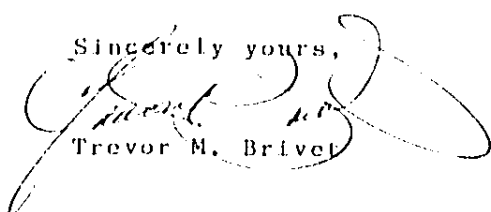

ARTICLE OF INCORPORATION
OF
SUNRAY TRANSPORTATION, INC.

95 AUG 28 AM 11:51

THE UNDERSIGNED, natural persons of legal age, acting as incorporators of a corporation under the laws of the State of Florida, adopt the following Article of Incorporation for such corporation:

ARTICLE I - NAME

The name of the corporation is SUNRAY TRANSPORTATION, INC.

ARTICLE II - DURATION

The period of its duration is perpetual.

ARTICLE III - NATURE OF BUSINESS

The purpose(s) for which this corporation is organized are:
"To operate a non-emergency transportation system, transport non-ambulatory, senior citizens, blind and handicap patients"
"And any other lawful business activity for which corporation may be incorporated under chapter 607 of the Florida Statutes."

ARTICLE IV - CAPITAL STOCK

The aggregate number of shares which the corporation shall have authority to issue is 100,000 shares of common stock having a par value of \$1.00 each.

Stated Capital: The sum of the value of all shares of common stock of the corporation, outstanding at any particular time shall be the capital of the corporation.

No Classes of Stocks: The shares of the corporation are not to be divided into classes.

No Shares in Series: The corporation is not authorized to issue shares in series.

Cumulative Voting: Cumulative voting of shares is not authorized.

Pre-emptive Rights: There are no provision limiting or denying to shareholders the pre-emptive right to acquire additional shares or treasure shares of the corporation.

ARTICLE V - REGULATION OF INTERNAL AFFAIRS

The internal affairs of the corporation are governed by the "BY-LAWS" which shall be established and approved by a majority of the directors at the First Meeting of The Board of Directors.

ARTICLE VI - REGISTERED OFFICE, MAILING ADDRESS AND AGENT

The address of the initial registered office of the corporation is 13579 Texas Woods Circle, Orlando, Florida 32824 and the name of its initial Registered Agent at such address is Trevor M. Brivet. The Principal place of business is 13579 Texas Woods Circle, Orlando, Florida 32824.

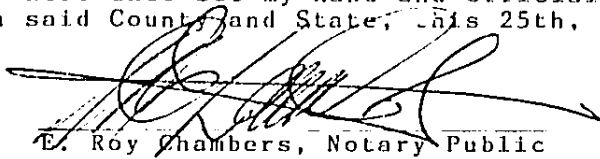
