NAME

The name of this corporation shall be:

NATURE OF BUSINESS

This Corporation may engage in any activity or business permitted under the Laws of the United States of America and the Laws of the State of Florida

ARTICLE THREE

TERM OF EXISTENCE

This Corporation shall have perpetual existence, unless sooner dissolved in accordance with the laws of the State of Florida. The date on which corporate existence shall begin is:
